- 1) The hall hire deposit and booking fee is:
\$500 per night (\$800 bond)
\$100 upstairs per day (\$100 bond) / \$100 downstairs per day (\$100 bond)
(Bond refunded when hall is left in the condition it was found in prior to the function).
- 2) Hall hire fee \$ for the period All loud music is to cease at midnight, hall to be locked and alarmed by hirer and vacated soon after unless otherwise specified above.
- 3) Hirer to ensure that all cooking facilities are turned off and clean after use.
- 4) Hall will be considered booked on receipt of deposit and signed contract. All remaining applicable fees are to be paid prior to hire date.
- 5) Hirer cleaning of the premises includes but is not limited to: sweeping and mopping all floors, toilet areas cleaned, furniture cleaned and stacked as found (if unsure image as found on Club website), kitchen area, cutlery and crockery, equipment and fixtures cleaned, Verandas cleaned and all rubbish removed from premises. (NOTE Council bins in park are not to be used for rubbish disposal.)
- 6) Hall hire deposit monies will be refunded when the condition of the hall and fixtures as listed above has been assessed and are in an acceptable condition. Any damage to any property of BSSLSC is to be rectified.
- 7) Hirer understands that in the event that the hall hire deposit does not cover costs arising through default. BSSLSC will hold the hirer liable for any balance outstanding.
- 8) The hirer understands that BSSLSC may terminate this contract if the hall is used for any other purpose than declared on this contract.
- 9) **PLEASE NOTE BSSLSC HAS A TOTAL NO SMOKING POLICY INSIDE THE HALL.**
