We all thank the Patrol Captains for their dedication and expertise in delivering safe swimming areas and preventative actions to protect the public. The Committee has had a strong strategic planning focus this year and is developing one-, three- and five-year plans to guide our growth and improved services to members and the community. These strategic plans will be formalised early in the next season. The Clubhouse renovation will form the foundation of a community asset and allow us to generate the funding, community interaction and member collective to operate a sustainable Club that supports and grows its members. I thank Claire Forbes for her contribution to gaining a series of Commonwealth, State and corporate grants to keep our strategic plans progressing and our equipment modern.



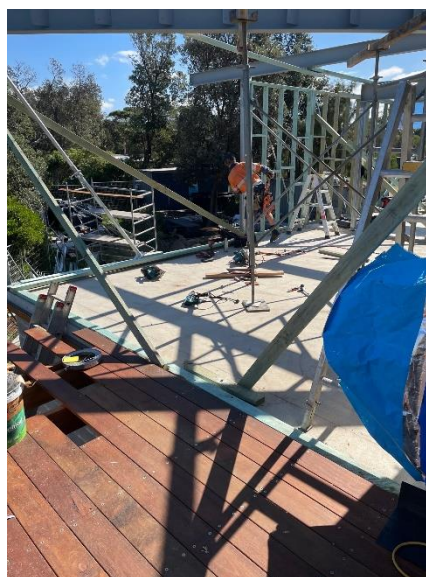

Our major projects this year have included the Clubhouse renovation, commissioning of the new SBS (ATV) vehicle, new constitution ratified, a Club History project, drafting a strategic plan, developing a focus on our surf sports, the 10th Annual Hotondo Bay to Breakers Ocean Swim, the Gear Shed Renovation and rainwater tanks, conducting the Branch Senior and Nipper Surf Carnivals on our beach and the clean-up of the rubbish in the area behind the Gear Shed. Thank you to all the members that led and helped with these projects.

The new constitution was developed following an extensive consultation and drafting process and was ratified at the May 2021 Special General Meeting (SGM). This new constitution replaces the 1993 Club

Constitution which was no longer aligned with current legislative requirements. Thank you to the Constitution Subcommittee for their efforts and thanks to David Butt and Claire Forbes for their contribution.

The Building Subcommittee under Al Veness' leadership has had a huge amount of work this year. The project management of the Clubhouse renovation has required considerable concentration and diligence as we managed building regulations, construction progress and project finances. At the time of writing, we plan to be in the Clubhouse in Q3 2021. The other major project has been the Crown Land lease for the area we occupy. We are working closely with the Eurobodalla Shire, NSW Lands and NSW Surf Life Saving to develop a new crown land lease. The good news is we are in the final stages for accepting a new lease that allows the Club and Café to operate successfully for the next 21 years.

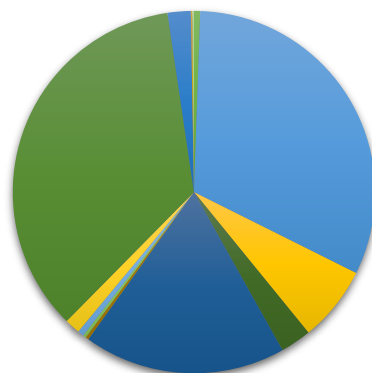

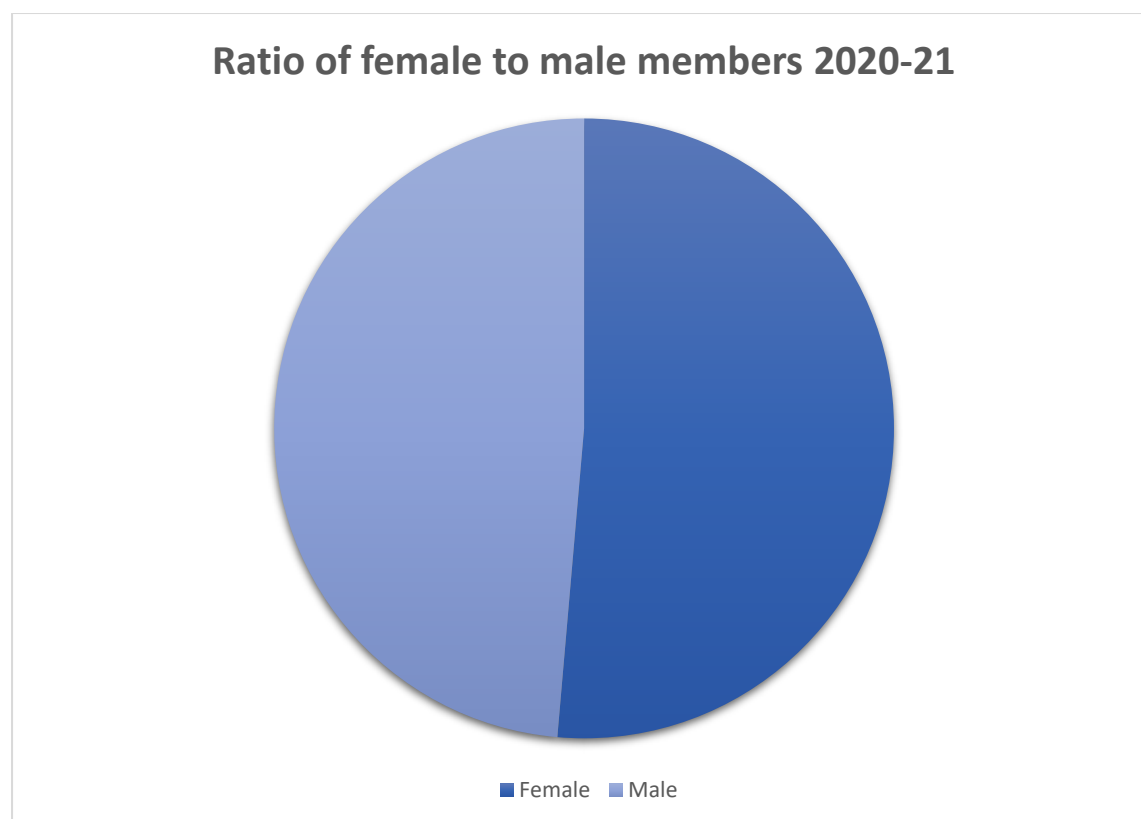

BUILDING COMMITTEE REPORT

The Building Committee has been busy this year obtaining grants and managing the upgrades to the club. In 2018-19 the Club was fortunate to receive \$350,000 as part of the Surf Life Saving Clubs Facility Grant Programs (funded by the NSW State Government Office for Sport) and in 2019 received additional funding from the Federal Department of Health (\$500,000) under the Community Water Safety and Female Change Rooms grant initiative.

In April 2020, the Club commenced a tender process for the build. Following the tender evaluation process in May 2020, Surf Life Saving NSW support was asked to provide the club with an independent evaluation of the tender evaluation process, and the tender responses received to assist the club in awarding of the contract. The tender responses had been through two independent club evaluation committees and considered by the club committee in full.

A report was provided by Colliers International in June 2020 which found that the club committee's evaluation that responder A was sound, that had correctly followed required procurement and tender evaluation processes, and that a repeated process would likely produce a similar outcome without clear resolution. As a result of the independent findings, the Broulee Surfers SLSC then executed a contract with P and L Louttit Construction Services in June 2020.

SLSNSW wrote to various NSW Government Ministers, the Federal Member for Gilmore and the ACNC advising them of the independent assessment findings into our tender evaluation and selection process.

On execution of the contract, it was established a revised Development Application would be needed with the Eurobodalla Shire Council which added several weeks before we were able to start the project. In December 2021 we obtained a BCA report and Construction Certificate to allow us to commence the build. The building was now classified as 9B, Commercial, which required significant upgrades to fire rating and emergency protections including additions to walls and ceilings, emergency warning and public address systems, hearing augmentation loops, fire hydrants, emergency signage and exits.

In November 2020, the Building Committee advertised a request for tender for a 10 year café/kiosk sublease. This RFT was released following consultation with the Eurobodalla Shire Council. The RFT closed mid December 2020, with negotiations occurring in February 2021 with the preferred supplier. We have signed a letter of intent and will formally issue a lease likely in August 2021.

Construction commenced with earnest following the Christmas shut down in February 2021 on the building extensions which include a new first aid room (with two treatment beds), new bar, larger function room, a third storey patrol room and observation tower, member change rooms and showers, and a new Café/Kiosk. The construction will allow the club to increase its capacity by 80% taking it to 180 persons in the function room and 195 people throughout the whole building.

The requirement for 9B building certification added complexity to the project, including a, at the time of writing this report, an unresolved issue relating to water pressure. In order to be certified as compliant our fire hydrants require water pressure and volume that can deliver 20 litres per second for four hours. We are continuing to liaise with Eurobodalla Shire Council to see if they are in a position to deliver that water via their existing mains and infrastructure or if the club will be required to install water tanks. If new tanks are required, the club will need to submit a revised development application with the shire which may increase the timings for project completion. All things going well we hope to open the new facility in late October/November 2021.

The Club was also fortunate during the year to receive bushfire resilience grant funding - \$25,000 from the Commonwealth Bank of Australia- which will be used to cover costs associated with hard wiring an automated backup generator for the building. We also received \$25,000 from News Corporation which will be used to upgrade appliances in the club kitchen.

The Building Committee would like to recognise Peter and Lee Louttit who have been incredibly accommodating with all the delays to the project which have largely been beyond the club's control. They have been incredibly supportive and wonderful partners in the project who share our vision in making the club as functional as possible and well set up for the next 30 years.

In addition to the building upgrade and café sub lease, the building committee has also been negotiating with the Eurobodalla Shire Council for a new lease, which will be five years initially and then for a further 21 years. This has been led by Allan Veness who has been very diligent in his discussions with Council, Surf Life Saving NSW and the Far South Coast Branch.

There was also substantial work with the NSW Office for Liquor and Gaming to obtain a revised liquor license for the new club house and outdoor areas which includes the grounds downstairs and gear shed and surrounds. A plan of management had to be developed with NSW Police and Eurobodalla Shire Council, however we are pleased to report the license is now in place.

BROULEE NIPPERS REPORT

Broulee Nippers season 2020-21 saw a record number of registrations over the previous year, with 145 registered nippers up from 119 last season. Strong participation throughout the year in the regular Sunday meets assured equally strong commitment at all three branch carnivals: Narooma, Broulee and Tathra.

The Nippers adopted their Covid 19 plan to ensure the safe participation for all. To keep numbers down and to keep within our covid plan, this season the Canberra/Broulee Nippers trained at Broulee on their monthly meets on Saturday's whilst the Broulee nippers trained on Sundays, however in March we were able to combine the teams to perform with great cooperation and tremendous growth in abilities from all participants, Age Managers and volunteers.

We faced some challenges this season, given there were many layers of complexities to design operational guidelines for this community sport to proceed whilst meeting health requirements. Nippers was one of the first sports in the area to completely fulfil all these requirements and be up and running by October. This season we completed a full calendar of 18 regular nippers' sessions as well as all three carnivals with excellent participation in all areas.

During the season we had a couple of rainy days that did not curb the enthusiasm of the nippers or their Age Managers. Only once was the beach closed but we managed a beach session all the same.

Outside of the season's challenges, the Broulee Nippers extended themselves in all surf sports disciplines, and tackled the first aid aspects in training for their SRC

qualifications. Thirteen under 14's completed their SRC this season. It is without any doubt that the

HOTONDO HOMES BAY TO BREAKERS OCEAN SWIM

The tenth annual Broulee Bay to Breakers Ocean Swim was conducted on Sunday 7 March 2021. After a summer impacted by the pandemic, the 10th swim was successfully managed with 358 swimmers on North Broulee beach.

The conditions at Broulee Beach were above the risk tolerance, with large 4 metre waves for ocean swimming on the advertised main swim course around the headland. The event was moved to North Broulee Bay for the safety of the swimmers and to remain within the risk tolerance. The North Broulee water was clear, calm with no waves and at 22.2C. The weather conditions were good at 26C, warm and little wind on the contingent swim course. The registration for our swim was closed one week before the swim and there were no walk-up registrations on the day. This made the administration simpler and more straightforward.

The sixth year of the Under 12 and 14 swim over 500m was conducted also at North Broulee with 34 swimmers.

The event was sponsored by Hotondo Homes (Principal Darren Phillips) as the major sponsor, and we were

supported by a larger number of local sponsors. Hotondo Homes are in the final of their third three-year major sponsorship agreement.

The organising committee were members from the Broulee Surf Life Saving Club. Unfortunately, the Broulee Mossy Point Community Association members were unable to assist with the swim this year due to the pandemic and concerns for the personal safety of community members. The Swim committee all did a fantastic job applying better practice and the lessons learnt from the previous swims to make this a better event. Dave and Rosemary Butt were the Swim Directors and their efforts were industrious and innovative this year. The timing system was managed and controlled by Ted Pettigrove after several test sessions and the event results were available a few minutes after the last swimmer crossed the line. A huge improvement on the operation of the system last year.

The swimmer's feedback was incredibly positive again this year.

A profit was made from the event was \$12,000 for the Broulee Surf Life Saving Club. Broulee Surfers SLSC then donated \$1000 to Broulee Mossy Point Community Association.

EVENT FACTS AND HIGHLIGHTS

- Naming sponsorship from Hotondo Homes and their logistics party were brilliant. An excellent relationship with benefits to both parties. The finish area and the archway look professional and worked well for swimmers
- 358 swimmers entered the water.
- Mixed age waves of 20 swimmers to comply with COVID rules
- 182 swimmers were male and 176 were female
- The Over 50 age division had 86 swimmers and Over 40 had 63 swimmers
- 79 swimmers came from Broulee, Mossy Point, Moruya and Batemans Bay
- James Thorp won his third Open Men's Swim and Grace Hoitink won her third open Women's swim in a row
- Swimmer pre-registration entry fee was \$45 and included T-Shirt, swim cap in a Woolworth's shopping bag
- Three of the ten Bay to Breakers Ocean Swims have now been conducted at North Broulee (30%) due to the higher potential risks to the ocean swimmers and water safety rescuers.

1 Summary of significant accounting policies

The association was incorporated 21 October 1988 (Y0616534) under the *Associations Incorporation Act 2009*, NSW. It is registered with the Australian Business Register - Australian Business Number 62 456 466 445. The association is registered for Goods and Services Tax purposes and reports quarterly on a cash basis. The association is income tax exempt under authority from the Australian Taxation Office. It holds an authority to fundraise through Surf Life Saving New South Wales Incorporated (CFN11033) under the provisions of the Charitable Fundraising Act 1991 and the authority remains in force until 6 May 2019.

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the *Associations Incorporation Act 2009* as above and *Australian Charities and Not-for-profits Commission Act 2012*. The committee has determined that the association is not a reporting entity.

The financial report has been prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following material accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

(a) Property, plant and equipment

The depreciable amount of all fixed assets are depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use. Donated assets are brought to account at fair value at the date of acquisition.

(b) Inventories

Inventories are measured at the lower of cost and net realisable value. Cost of inventory is determined using the first-in-first-out basis and is net of any rebates and discounts received. Net realisable value is estimated using the most reliable evidence available at the reporting date and inventory is written down through an obsolescence provision if necessary.

2 Information and Declarations to be furnished under the *Charitable Fundraising Act 1991*

During the year the organisation obtained net income of \$127,438 for charitable purposes. Of this income \$1,327 was used for fundraising expenses. The surplus was used for equipment purchases and maintenance. Fundraising efforts conducted included sponsorship and donations, various functions and product sales.



- (a) giving a true and fair view of the Entity's financial position as at 30 April 2021 and of its financial performance for the year then ended; and

Basis for Qualified Opinion

We have also fulfilled our other responsibilities in accordance with the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Report on Other Legal and Regulatory Requirements

We report that:

- (a) the financial statements show a true and fair view of the financial result of fundraising appeals conducted during the year;
- (b) the accounting and associated records have been properly kept during the year in accordance with the *Charitable Fundraising Act 1991* (NSW) and regulations (as amended);
- (c) money received as a result of fundraising appeals conducted during the year has been properly accounted for and applied in accordance with the *Charitable Fundraising Act 1991* (NSW), and regulations (as amended); and
- (d) at the date of this report, there are reasonable grounds to believe that the association will be able to pay its debts as and when they fall due.

Information Other than the Financial Report and Auditor's Report

Those charged with governance are responsible for the other information. The other information comprises the information included in the Entity's annual report for the year ended 30 April 2021, but does not include the financial report and our auditor's report thereon. Our opinion on the financial report does not cover the other information and accordingly we do not express any form of assurance conclusion thereon. In connection with our audit of the financial report, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial report or our knowledge obtained in the audit or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of this other information; we are required to report that fact. We have not received any Other Information as at the date of this audit report and as such have nothing to report in this regard.

BIOGRAPHIES OF LIFE MEMBERS ELECTED IN 2020

Allan Veness

Allan has been an active member of the Broulee Surfers SLSC since obtaining his Bronze Medallion in 1984. He has served in many roles within the club including Patrol Captain of Patrol 1 for many years, training officer/assessor for almost 20 years. He's even proved quite handy on the BBQ cooking up a feast for Patrol One many times. He is the second longest serving president in the Club's history- from 2012 to 2019, and continued to serve as Vice President, Acting President, and chair of the Building Committee. In 2006 Allan was recognised as the patrolman of the year.

Allan this season will receive his 25 year National Patrol Service award. In all of those 25 years Allan has maintained an almost an exemplary 100% patrol attendance in hours volunteered for each year of patrols.



The record keeping doesn't go back too far, but Surf Guard shows Allan has run 18 Bronze Medallion courses as Trainer or Assessor – and we're sure that actual number of courses and members taught by Allan would be even greater. In his years as Trainer, Assessor and Facilitator Allan has helped out with new courses and of course every year giving up many weekends to ensure our annual proficiencies are conducted. Allan has 61 awards in Surf Guard including Bronze Medallion, IRB crew, Patrol Captain, First Aid, Spinal Management, Trainer and Assessor, Certificate IV in Training and Assessing.

Under Allan's stewardship as President the Club has achieved many significant achievements including the Phase One Club House Redevelopment, Phase Two Clubhouse redevelopment, Renovation of the Gear Shed, introduction of the Broulee Bay to Breakers Ocean Swim, introduction of the Canberra Nippers initiative, and a healthy membership base.

Allan has continued to assiduously drive negotiations with the Eurobodalla Shire Council to achieve an equitable lease on behalf of the club. These negotiations have been unresolved since 1985, but thanks to Allan's efforts we are hopeful will be resolved soon.

Allan remains to be an active patroller, assessor, acting Club President and Committee Member, and is leading the rebuild of Phase II of the club redevelopment on the Building Committee. He is also an avid participant in the Sunday Morning Swim sessions at Broulee Beach.

Darren Browning

Darren has been an active patrolling member of the Broulee Surfers SLSC for the past 15 years. He has served in many roles within the club including Patrol Captain of Patrol 3 for over a decade, Northern RWC Coordinator, Nippers Age Manager and Coordinator.

Darren was a member of the Broulee Surfers SLSC Committee for over a decade, holding the position of secretariat. During this time, he was involved in many significant milestones for the club, including the Phase One Club House Redevelopment and the renovation of the gear shed.

- In 2010 Darren was recognised as the club's Patrolman of the Year.
- In 2012 Darren was recognised as Club Person of the Year.
- In 2017 Darryl was recognised as the Branch Overall Competitor of the Year.
- In 2017 Darren was recognised as the Branch Lifesaver of the Year.



Darren was the Nippers Coordinator and an Age Manager from 2006-2013. During this time he mentored, coached and developed over 30 Nippers (one of the largest nippers age groups the club has had) and ran multiple inter-club training sessions for others on the Far South Coast. He played a significant role in introducing the Bateman's Bay nippers to the club when their program folded.

Darren has maintained an almost exemplary 100% patrol attendance in hours volunteered for each year of patrols since he obtained his bronze medallion, receiving continuous 5 year 100% patroller from the club in a previous season. He has also mentored and encouraged numerous other patrol captains, patrolling members, cadets and their parents over this time, providing training and guidance to help them achieve awards such as IRB Driver/Crew and RWC as well as becoming competent patrolling members and leaders of the club. A testament of this is a number of members of Darren's patrol receiving the club's Junior Lifesaver of the Year award the past few seasons.

Darren was one of the branches original RWC operators, achieving this award in 2009. Darren has been an integral part of the club and branches emergency call out and support operations team for over a decade. Major incidents he has been involved in include; the plane crash at Barlings Beach, upturned

boat at Broulee, fire response at Durras, fire response at Broulee, body searches at Moruya, Narooma and Tuross and numerous search and rescue callouts in many years as an RWC operator.

Darren is always one of the first to put his name down for water safety for the Broulee Bay to Breakers Ocean swim, junior and senior carnivals and nippers. He is also always the first to lend a helping hand with anything around the club, something that was particularly evident in this year's response to the bushfires. Darren was responsible for the relocation of assets such as a RWC, IRB, first aid kits and oxygen to Tomakin and operating the clubhouse as a recovery centre in the weeks after the firestorm. On top of this, he has been recently responsible for facilitating and providing brand new sheds to numerous local families who lost a significant amount during the fires.

In his time at the club, Darren has given up numerous weekends to ensure annual proficiencies are conducted, trained multiple members in their RWC course, ran cadet training sessions and conducted maintenance of equipment such as IRBS, call out gear, the gear shed and radios. In addition to these jobs, Darren is the Northern RWC Coordinator, responsible for the maintenance and upkeep of the RWC and call out gear.

Darren has 64 awards in Surf Guard including Bronze Medallion, Silver Medallion, Gold Medallion, IRB Driver, IRB Crew, Patrol Captain, First Aid, Spinal Management and RWC Operator. He has completed over 750 patrol hours in the past 10 years.

In further contribution to Surf Life Saving, Darren is a keen surf sports competitor and contributed significantly to the club retaining the Jack Beale Trophy for multiple consecutive years. He has represented Broulee Surfers SLSC at Branch, Country, State and Aussie championships as well as completing four Coolangatta Golds for the club. Further to the numerous branch, country and state medals he has won, Darren placed third in the O50s male flags at the Australian Championships in 2017.

In further Community Service recognition, in 2018 Darren was selected to participate in the Queens Baton Relay for the Commonwealth Games, recognising his contribution to surf lifesaving.

Peter Halkett has been a devoted member of the Broulee Surfers Surf Life Saving Club Since Transferring from Batemans Bay in 1999. Peter did over a decade as patrol captain of Patrol 8 since 2006 and has maintained an extremely diligent patrol service record in his 20 plus years minimum as a member. He has completed a total of 658 patrol hours. Peter was an inaugural member of the Broulee SLSC Club callout list and has been involved in a significant number of incidents. He also holds his Rescue Water Operator Certificate.

From there his records are a bit all over the shop however this year Peter will obtain his 20-year National Patrol Service Award having never missed a season patrolling at Broulee since 1999.

Peter has helped as Nipper Age Manager, Duty Bar Manager, Water Safety and Club fundraising events such as annual door knocks or working bees. He is always one of the first members to put his hand up to help with water safety at club and branch carnivals.

Even this season, Pete tore his bicep in the notorious surf at Coila Beach, in an act he did to protect the four rowers who he was ferrying to the beach. Without his intervention there could have been a much more serious injury to all the vessel occupants. Despite Peter's injury he still helped at the Broulee Bay to Breakers Ocean swim, in a 'spotting' capacity just to help us out.

Peter has driven an IRB many times for the George Bass Marathon supporting Broulee crews, and even competed in the Bass as a rower.

Peter and his wife Robyn have been tremendous members of our club. Robyn previously served as Club Treasurer and remained an active patroller for many years along with their children Jess and Lauren.
