Presidents Report 2017-2018

The 2017-2018 has been another successful season and one that we can all be proud to have played a role in achieving the club's goals. Broulee Beach has been fatality free which is a great result considering visitor numbers were significantly up on last year. A surf club is an emergency service first responder but is also a surf sports club, a social club and also an organisation that fosters and develops the skills of young members. An outline of the club's activities follows.

Patrols

I thank all patrolling members who have given freely of their time and taken on the responsibility of looking after others on our beach. There were 184 patrolling members who have completed 5,377 patrol hours for the season. 166 preventions, 48 rescues and 21 first aid responses were performed and this shows the importance of the work we do. The records show that 26,878 people visited our beach during patrol hours this year. This is over 6,000 more than last year.

In addition to scheduled patrols, some members have responded to emergency call outs. One recent example was a boating accident at the Moruya River Mouth where members of Moruya, Batemans Bay and Broulee clubs attended.



Membership

We are a big club. We have 653 members in total which includes 246 nippers, 211 associates and 184 patrolling members. Within this number is included 123 Canberra based nippers and their families. The proportion of our members who are based in Canberra continues to grow in number and significance within the club. Members all contribute in many different ways and the club thanks everyone for their efforts during the season.

Trainers and Assessors

The team of trainers and assessors have had a very busy season. There were 593 proficiencies done which included 286 nippers' swims. There were 371 new awards which included 208 nipper awards. Special thanks to Kel Pearce, Mick Lambert, Peter Halpin, Craig Goddard, Nick Goddard and Gary Pettigrove.

Without the trainers carrying out the annual proficiencies and assessing members for new awards, we simply would not have people on the beach capable of patrolling.

Nippers

We are unique in that we have Nippers made up of two distinct groups. As well as our Broulee based Nippers, there is also a Canberra based group of approximately 120 nippers, plus parents and helpers. The two groups work well together and the contribution of this combined group is vital for the future of the Broulee Club. I thank parents, water safety volunteers, age managers, carnival officials and all who have played a role in this group. Special mention must be made of Scott and Simone Elliott who coordinate the Broulee based group and Steve Corcoran with his committee who have coordinated the Canberra group. I also thank Bethany Williams for her vision and work in establishing the Canberra Broulee Nippers.

It is important to make special mention of Amanda Smith who after three years as water safety coordinator has retired from that role. Also, Scott Elliott and Dave Hosking who have been age managers of their group for the past seven years. Your contributions have been huge and much appreciated.

Surf Sports

It was a busy year for the club's competitors. There were local carnivals, Country, State and Aussie carnivals. In addition, boat crews participated in Ocean Thunder, South Coast boat series and four crews also rowed in The George Bass Marathon. The Broulee Men's Vet team of Morgan Freemantle, Steve Moore, Jeff Dunne, Peter Shaw with sweep Gary Pettigrove were the most successful competitors for the year with a bronze medal at the recent Aussies Carnival, Branch Vets champions, fourth in the ASRL and winners in the South Coast Boat series. Many other competitors also had good seasons and helped Broulee to be a major force within our branch. Sadly, I have a feeling that we may have lost the Jack Beale trophy for the first time after eight straight years.

Thanks to all those who competed and to those who officiated at carnivals.

Hotondo Homes Bay to Breakers Ocean Swim

The seventh annual ocean swim attracted a record 320 swimmers. The event was held in near perfect conditions and many records were broken. Callum Elliott won the men's open event in 18min 41 sec. This was an amazing swim considering he is still 13 years old. Feedback from competitors was very positive especially with record keeping and water safety.

This event is a major fund raiser for the club and it would not be possible without the work of the swim committee and the Broulee and Mossy Point Community Association. Once again, this group was chaired by Gary Pettigrove who contributed a huge amount of effort, time and skill to this event.

Sunday Swim

The summer series Sunday swim competition has continued to be popular. Up to 50 swimmers have competed on some days and the competition has been hotly contested. Cherise Walker has been the organiser and chief handicapper this season and the club thanks her for her contribution.

Club Committee

The club committee ensure the smooth running of the club. Each member not only looks after a specific part of the club's activities, but also contributes to making decisions that influence the whole club. Their level of commitment is shown in the many hours of work that they contribute and also in the manner in which decisions are made so that the club's best interests always is the main consideration.

I would especially like to thank the following people who have shouldered the bulk of tasks in running our club.

1. Wendy Law; who is our secretary and has contributed in the organisation of Nippers (Canberra and local), Surf Sports, training and assessing, assisted our registrar and has also been an official at carnivals.

2. Lynda McKay; who has performed the task as treasurer in exemplary fashion.

3. Andrew Mizzi and Kirsty Campbell; who have organised and overseen the running of patrols during the season.

General Helpers

Once again, a big thank you to all who have quietly done the many tasks required to keep our club running. This includes the bar, BBQs, maintenance of buildings and of our gear, and the boutique. Without these volunteers, our club would find it difficult to function.

Challenges

Whilst the club continues to grow and to function efficiently, there are a number of challenges we must consider. These include,

- Ensuring we have adequate members on patrol at all times.
- Ensuring that each patrol has people with required awards and skills.
- Increasing participation of members at branch carnivals.
- Increasing the number of carnival officials from our club.
- Retaining members, especially those moving from Nippers to the senior ranks.
- Getting new people to take on the major roles within the club.

Thanks to all for another good year. It is a pleasure to belong and to contribute to such a great organisation.


SECRETARY'S REPORT 2017-2018

For the year ended 30 April 2018

1 Summary of significant accounting policies

The association was incorporated 21 October 1988 (Y0616534) under the Associations Incorporation Act 2009, NSW. It is registered with the Australian Business Register - Australian Business Number 62 456 466 445. The association is registered for Goods and Services Tax purposes and reports quarterly on a cash basis. The association is income tax exempt under authority from the Australian Taxation Office. It holds an authority to fundraise through Surf Life Saving New South Wales Incorporated (CFN11033) under the provisions of the Charitable Fundraising Act 1991 and the authority remains in force until 6 May 2019.

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act 2009 as above and Australian Charities and Not-for-profits Commission Act 2012. The committee has determined that the association is not a reporting entity.

The financial report has been prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following material accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report:

(a) Property, plant and equipment

The depreciable amount of all fixed assets are depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use. Donated assets are brought to account at fair value at the date of acquisition.

(b) Inventories

Inventories are measured at the lower of cost and net realisable value. Cost of inventory is determined using the first-in-first-out basis and is net of any rebates and discounts received. Net realisable value is estimated using the most reliable evidence available at the reporting date and inventory is written down through an obsolescence provision if necessary.

2 Information And Declarations to be furnished under the Charitable Fundraising Act 1991

During the year the organisation obtained net income of \$46,339.90 for charitable purposes. Of this income \$0.00 was used for fundraising expenses. The surplus was used for equipment purchases and maintenance. Fundraising efforts conducted included sponsorship and donations, various functions and product sales.

Our nippers have developed a range of skills in the ocean, and love joining in with the Broulee
